Dear Mr. Stutzman:

During 2005 I was approached by the Chairperson of the Franklin County Republican Central Committee, she advised that no one was steeping forward to be the Treasurer for the committee and that she was appointing me to be the Treasurer. I asked her about the filing status of our committee with regards to the Public Disclosure Commission. She directed me to a former Treasurer, he advised that he had not filed any paperwork with the PDC, I asked if we were required to and he was not sure. I made contact with the Treasurer of the Benton County Republican Central Committee in late 2005, she advised that we needed to file and that it had to be done electronically. I met with her in early January 2006 and she showed me how to access your web site and down load the program. I filed the C1pc form and registered for an account and password with the PDC. At that time I registered the committee as full reporting unaware that mini reporting was available. While I was waiting for the password, etc. from the PDC to perform the electronic filing, I was given all of the financial records for the committee and discovered that they operated on less than \$3500 per year, I did some further checking and discovered that we could do mini reporting. I then filled out another C1pc amending the original Clpc. I was under the impression that I would be receiving the necessary information from the PDC to perform the electronic filing within a few days. I sent an email and asked for contact by phone at my residence, several more weeks went by and I sent another email and left my cell phone number for a contact. I received a message on my cell phone with the information I needed and in the message the person who called back stated that they had left the information previously on my home phone message receiver. The only problem with that was that I have never had a message system on my home phone. At that point I filed the amended C1pc or at least I thought I had. I did have trouble getting it to send but I thought it had been sent. I am enclosing the form as saved on my computer in your program.
