



Dear Mr. Beatty:

In addition to this letter, I have attached to this e-mail and in PDF format the following, to-wit:

1. An Amended C1 requesting that I be allowed to change my reporting to Full Reporting.
2. Forms C3 and C4 with attachments thereto.
3. A copy of a letter I both mailed and e-mailed to my opponent in the general election and her e-mail back to me evidencing her receipt of the same.

I am prepared to mail the hard copies as soon as you have indicated to me that my documents are complete. I apologize for filing this at the last minute.

I did have some problems with how to handle loans I personally made to the campaign that were reimbursed to me by the campaign. I had to make charges on my personal credit card and I then had the campaign reimburse me. I wasn't quite sure how to handle this. I showed the loans on Schedule L but I made no reference to them on Schedule C4. I assumed that since there were no moneys actually deposited into the campaign account there would be no need to include them on the receipts and expenditures schedule. Form C4 accurately represents all campaign contributions received, and deposited into the campaign account, together with all expenditures made to date. I assume if I didn't reflect this correctly you will let me know.
