Dear Mr. Perkins:

We are the Co-Chairs of the Citizens Committee for Good Schools. Our Committee has been supporting the Vancouver Public Schools with raising monies for its levy and bond campaigns for over 20 years. We have historically been an "ad hoc" committee in the sense that we form for a particular levy or bond campaign and then end our activity at the close of the election. While we have always filed our PDC reports on a timely fashion and take these reporting requirements seriously, we have recently discovered that reports relating to our 2006 and 2010 campaigns have not been filed. We are writing to comply with the reporting requirements and also provide you an explanation for the delay.

The good news for us is that the lack of reporting for these years is not related to any malfeasance within our Committee. Quite simply, the person charged with handling the financial bookkeeping and PDC reporting did an excellent job of maintaining the finances for our Committee, but did not file the reports for the 2006 and 2010 campaigns. Please know that we have instituted new systems to provide for double accountability with regard to the PDC reporting. We simply cannot rely on one person to assure compliance in this area. These changes are already in place and will assure compliance going forward. In fact, our Committee has decided to change from an "ad hoc" committee and become a "Continuing" Committee. As a result, we will be making regular monthly PDC reports.

All the data for our 2006 and 2010 campaigns have been summarized on Excel spreadsheets, copies of which are enclosed along with an updated Political Committee Registration form. We are happy to provide this in electronic format if needed. We do know that the current PDC system provides for on-line reporting. We reviewed the system to see if the reports we needed to file could be filed on-line, but we could not identify a way to do so. Given the extent of the data we are hopeful that our spreadsheet will suffice, but we will work with you on whatever is needed to complete the filing requirements.
