## **Addendum to C1PC for Voters Want More Choices**

October 20, 2017

Dear Public Disclosure Commission:

One of our committee's activities this year is promoting Initiative 947 which limits certain vehicle taxes and fees. I-947 is an initiative to the legislature and, if it qualifies, it will be voted on in November, 2018.

In January 2017, after extensive discussions with the Attorney General's office following various complaints in 2016, I was told by the AG's office through our attorney to file Voters Want More Choices as a continuing committee starting this year. The AG's office said that they no longer wanted me to create a new ballot measure committee for each initiative - they preferred that I have one continuing committee to handle all the reporting of our various activities.

On the C1PC form for a continuing committee, there is no box to report if our continuing committee is also promoting a ballot measure. I previously sent your office a letter asking you to add an extra page to our C1PC form that said our committee, among its other activities, would be promoting Initiative 1550 which reformed property taxes. I have been told that our committee does not appear in the search function of the "Ballot Committees" portion of your website. I would respectfully ask that you consider changing this in light of the above.
