A reminder from the Public Disclosure Commission for Mini Reporting Candidates:

If your name appears on the general election ballot, * **Tuesday, September 25, 2007**, is the last day to change from Mini Reporting to Full Reporting before the election.

The Mini Reporting option limits you to:

- raising no more than \$3,500 in monetary and/or in-kind contributions;
- accepting no more than \$300 in the aggregate from any one source other than the candidate; and
- spending no more than \$3,500, including the candidate's personal funds.

Do not accept a contribution that will cause you to exceed the mini reporting limits until you have approval from the PDC to change reporting options.

In order to change from Mini Reporting to Full Reporting, you must:

- ✓ • Notify your opponent in writing of your plan to change reporting options;
- ✓ • Send a letter to the PDC confirming how and when your opponent was notified that you are changing reporting options;
- ✓ • File a new Candidate Registration (C-1) form with the PDC and the county elections officer; and
- ✓ • File a C-3 report and a C-4 report with the appropriate schedules for the entire campaign. Be sure to report every contribution received and expenditure made by the campaign up to the day of your request to change reporting options. File these reports with the PDC and the county elections officer.

FAXED TO PDC ON 9-21-07

Deliver your request and completed forms to the PDC office no later than **Tuesday, September 25, 2007**, if you wish to change reporting options before the election.

Approval will NOT be granted if your application is received after Tuesday, September 25, unless:

- PDC staff did not notify you of the deadline for changing reporting options;
- A write-in opponent files for the office you are seeking on or after September 26;
- An independent expenditure is made in support of your opponent or in opposition to you on or after September 26; or
- Your opponent(s) requests and is approved to change reporting options.

*We are just receiving the certified results from the county election officials and there was not enough time to process them all before this notice had to be sent to the general election candidates. Please ignore this notice if you are not a general election candidate.


